**NOTIFICATION OF EVIDENTIARY HEARINGS BY THE CALIFORNIA PUBLIC  
UTILITIES COMMISSION (CPUC) IN  
APPLICATION 05-08-021/INVESTIGATION 06-03-001**

CPUC Decision 08-06-024 in A.05-08-021 granted limited rehearing of CPUC's Rules of Practice and Procedure Rule 1 issues related to Fontana Water Company's purchase of real property from Rosemead Properties, Inc. (Affiliate) and the adequacy of its disclosures regarding the Affiliate transaction in the General Rate Case (GRC) proceeding in Application 05-08-021, filed August 5, 2005. CPUC Decision 08-06-024 granted a limited rehearing to consider whether any violations occurred relative to its purchase of real property from the Affiliate. Thus the CPUC has scheduled the Evidentiary Hearings (EH) for the above proceeding. Beginning Monday, June 29, 2009 at 10:30 a.m. and if necessary continuing on June 30, 2009 the EH's will take place at the location noted below:

EH's are held whereby parties of record will present their testimony and will be subject to cross examination before the assigned Administrative Law Judge (ALJ). These EH's are open to the public to listen to, but only those persons who are formal parties of record can participate in this process to present evidence or cross-examine witnesses. If you wish to become a formal party in this formal application proceeding and participate in the EH's, please contact the Public Advisor's Office (PAO) at the address shown below. After considering all proposals and evidence presented during the EH process, the assigned ALJ will issue a proposed decision. The CPUC may approve the proposal as written, or the assigned Commissioner may issue a draft decision that differs from that of the ALJ. The CPUC's final decision may be different than the proposed request.
