Purpose and Background

To address Governor Schwarzenegger’s Executive Order S-06-08¹, the DWA requested that each Class A and B water utility file a Tier 2 advice letter to expedite the authorization of Rule 14.1. In response to the DWA request, San Gabriel files this advice letter requesting the addition of Rule 14.1 to its tariffs. The addition of Rule 14.1 permits San Gabriel to expedite the implementation of a voluntary water conservation or rationing plan in the event of a water shortage.

¹ Executive Order S-06-08 addresses water supply shortage in California, the various consequences of this shortage and ways in which state and local government entities shall address these concerns.

If a water shortage occurs, San Gabriel will notify the DWA of its intent and commence a public hearing and customer notification, as required.
